Instructions for Letters of Intent (LOI)

Submission Deadline: September 30, 2021, 11:59 PM EST

Letters of Intent (LOIs) in PDF format including the information described below in the specified format should be sent by September 30 (11:59 PM EST) via email to Marcia Cleary, the EMZ Foundation Administrator at: <u>mcleary@swisher.com</u>. LOIs will be reviewed by the EMZ Foundation Scientific Advisory Committee, who will notify applicants by October 15 if they will be invited to submit a full grant proposal application. Invited (full) applications will be due on November 15, 2021.

FORMAT FOR THE LOIS:

Please include the following in your Letter of Intent. Margins should be at least 1/2" around, and the suggested font is Arial, 11 point.

1. Face Page

The face page should include the following information:

- Title of the Project
- Name of Principal Investigator and Title, Degree
- Principal Investigator Contact Information: Mailing Address; Phone Number; Fax Number; email address; Web site address.
- 2. Biographical Sketch: Use the current 5-page National Institutes of Health (NIH) <u>Biosketch format</u>. This format includes a description of your training, a personal statement that describes your professional experience and its relevance to this project, and a description of up to 5 contributions to science with up to 4 supporting references each. Be sure to include a link to your complete bibliography. Example and template <u>NIH biosketch</u> format pages and instructions can be found here: grants.nih.gov/grants/forms/all-forms-and-formats.htm.
- 3. Current Funding ('Other Support'): Include a description of all current funding, including startup ('seed' or 'dowry') funding from your home institution, using the current NIH <u>Other Support format page</u>. Include the funding agency, award number, dates applicable, title, amount, and one or two sentences describing the content of the funded application/award. Instructions for how to fill out an NIH <u>Other Support format page</u> can be found here: https://grants.nih.gov/grants/forms/othersupport.htm.
- **4. Project Summary:** Two-page maximum (not including references). Please use Arial, 11-point font. Figures and tables are acceptable if they fit within the two page limit along with the text.

Suggested Format for Project Summary:

- 1. Brief summary of the background of the proposal.
 - Briefly describe the context of the scientific problem.
- 2. Description of the Hypothesis/Specific Aims of the project.
 - Indicate the specific hypothesis or questions to be addressed.
- 3. Rationale.
 - Explain the rationale leading to the proposed research.
- 4. Experimental Approach/Methodology
 - Provide a framework for the experimental plan, with references where appropriate.
- 5. Summary and Impact
 - How will the successful completion of the proposed studies advance our understanding of vision or visual system disorders?
